

**Zhengzhou Municipal Management Committee of Re-education  
through Labor  
Decision Statement of Re-education through Labor**

Zheng Lao Zi [2009] No. 0484

June 25, 2009

Feng Lu is a female born on April 17, 1968. She is of Han nationality and has completed an education in undergraduate program in college. Her ID No. is 410111196804170047. Her household registration is at 21, Building 37, Jinshui Road, Jinshui District, Zhengzhou city.

The following are facts of violation of the law by Feng Lu as concluded by Jinshui District Public Security Branch:

On December 23, 2008 it [Rock Church] was abolished in accordance with law by Jinshui District Bureau for Ethnic Religious Affairs of Zhengzhou Municipality. At about 9 a.m. on June 14, 2009, over 100 people engaged in religious activities at East House on the 3<sup>rd</sup> floor, West House on the 6<sup>th</sup> floor and East House on the 7<sup>th</sup> floor of Unit 1, Building 1, Courtyard 326, Nanyang Road, Jinshui District that were rented by Dou Shaowen and his wife Feng Lu. They were caught on the spot by Public Security departments.

Feng Lu has confessed everything to the above facts of violation of the law.

It is found out by this committee: In 2005, Dou Shaowen and his wife Feng Lu jointly founded Rock Church of Zhengzhou in their own house. On December 23, 2008, it was abolished in accordance with law by Jinshui District Bureau for Ethnic Religious Affairs of Zhengzhou Municipality. However, Dou Shaowen and his wife continued to organize people to engage in religious activities. At about 9 a.m. on June 14, 2009, over 100 people engaged in religious activities at East House on the 3<sup>rd</sup> floor, West House on the 6<sup>th</sup> floor and East House on the 7<sup>th</sup> floor of Unit 1, Building 1, Courtyard 326, Nanyang Road, Jinshui District that were rented by Dou Shaowen and his wife Feng Lu. They were caught on the spot by Public Security departments.

The above facts are corroborated by the statement of Feng Lu, the actor of the violation of the law, testimonies from witnesses, photos of material evidence and other materials.

The facts on this case are clear and evidence is accurate and sufficient. Therefore, the conclusion that the conduct of Feng Lu was disrupting the order of life should be made.

Pursuant to Item 5, Article 10 and Article 13 of the "Pilot Program of Re-education through Labor," it is now decided that Feng Lu be sentenced to one year of re-education through labor. Feng Lu, the person now sentenced to re-education through labor, was placed on administrative detention before this decision on re-education through labor. The term of the re-education

through labor is to be shortened by one day for each day spent in detention before the decision. The term of the re-education through labor starts on June 14, 2009 and ends on June 13, 2010.

As there is a child in Feng Lu's family that needs care, it is decided to execute the program of re-education through labor on Feng Lu outside the pursuant to Article 54 of "Public Security Departments on Measures of Execution of Re-education through Labor outside the labor camp. In case of an objection to this decision, one may apply for an administrative reconsideration at Zhengzhou Municipal People's Government or Henan Provincial Management Committee for Re-education through Labor within sixty (60) days from the second day of receiving this decision or one can directly submit an administrative lawsuit at the People's Court within three months of receiving this decision.
